 Community Champion Award

She has worked for local, regional and an international CPA firms, starting when attending SF State and retiring 12/31/18 from Marcum LLP. She has been primarily in the assurance side of the business with strong tax and consulting emphasis. Industries served have been healthcare, finance and technology. She has been active in community and faith based not for profits over the same time frame being a sought after board member and officer. She enjoys local and international travel with a 2nd home in Argentina.



Donald Endo
 Outstanding Public Accounting Award

Upon his graduation from SFSU, Donald Endo (B.A., '81) joined the international accounting firm of Laventhol and Horwath and was a member of the tax group from 1981 until 1990 when the firm merged its practice with BDO USA, LLP, where in 1985, Don became a partner in their tax practice.

In 1986, Don joined QAG, Inc. as their CFO, where he provided financial and tax oversight. Don also served as a member of the Board of Directors of companies held within the organization, including Credit One Bank, and served as chairman of the audit committee. In 2013, Don returned to BDO USA, LLP as Managing Director in the tax group, where he served as a tax adviser to corporate, venture capital and private equity clients. In addition, Don was the Core Value Champion for the San Francisco office tax group, providing leadership and mentoring within BDO's National Core Value Leadership program.

Don has served as a director on the Community Advisory Board for Wells Fargo Bank in the Bay Area market. Currently, Don is an active member of the San Francisco State University Foundation and serves on the Foundation's audit committee.

Jiunn Huang, Ph.D.

Distinguished Service
Accounting Professor Award

Dr. Jiunn C. Huang, Emeritus Professor of Accounting, joined San Francisco State in 1986 and retired in 2018. His primary teaching areas were cost accounting and international accounting. He published numerous articles in accounting education and financial reporting. Jiunn served as department chair for 19 years, effectively making committee assignments to accomplish department functions, such as RTP, hiring, and curriculum development. He actively engaged students beyond the classroom through student organizations. Jiunn regularly conducted outreach to accounting professionals and alumni to build strong ties, resulting in more students being hired and increased scholarship opportunities. During his tenure as chair, donations and contributions from firms and individuals were the highest in the history of the accounting department.



Joanna Duke, Ph.D.

Distinguished Service
Accounting Professor Award

Prior to serving as the Faculty Director of Graduate Business Programs, Jodi Duke served as Acting Associate Dean of the College of Business during the 2011 to 2012 academic year. While director of the Master of Science in Accountancy program, the MSA program grew from about 15 students in 2010 to almost 100 in 2013. Duke joined the department of accounting in 1987 after earning her Ph.D. from The Pennsylvania State University. Her primary teaching area is financial accounting and has taught courses from basic financial accounting, theory, and advanced topics. She has received a number of awards for teaching, advising and research. She has published widely on a variety of topics including bond covenants and the impact on accounting choice, financial effects of leasing arrangements and attributes affecting academic success. Her articles have appeared in several highly ranked journals including Journal of Accounting and Economics, Journal of Business, Finance and Accounting, Journal of Education for Business, and Advances in Accounting, among others. One article was reprinted as a chapter in the book "The Economics of Accounting Policy Choice". Duke retired from San Francisco State University in January 2018.



Loretta Doon

Lifetime Achievement Award

Loretta Doon (M.A., '73) began her executive role with CalCPA and the Foundation in 2005 as Chief Operating Officer (COO) and was named CEO of both organizations in May 2006, marking the first time in CalCPA's history that a CPA has held the CEO position. She began her career as a controller for an insurance company, followed by three years as an auditor at Ernst & Young.

Loretta went on to spend more than 25 years as the associate executive director of the California Teachers Association. She is also a former teacher. Loretta is recognized for her many achievements as head of CalCPA and the Foundation, including surpassing a record-setting 45,000 in membership and purchasing their headquarters building in Burlingame. She has been named one of Accounting Today's Top 100 Most Influential People in Accounting numerous times. Doon was also the chief architect for constructing a platform that attracted 53 education partners across the country, including 48 state CPA societies, 4 associations, and 1 national CPE vendor.

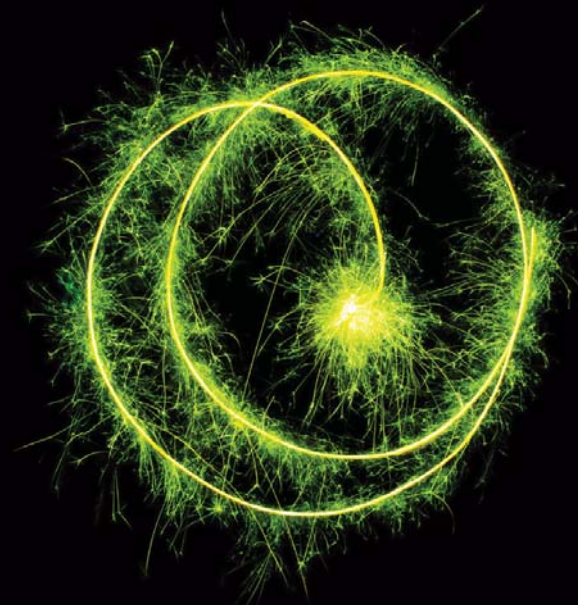

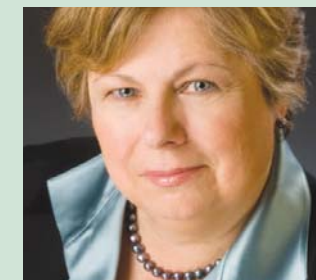
